The information noted in the **Contents** column of Record Type, Addenda Type Code, Segment Identifier, and Amount Type (Field TXP04) is constant information and **must** be included in the TXP Addendum Record.

The following is an example of an addendum record transmitted for an FTB payment:

Description of TXP Addendum Record Fields

Field #	Description
TXP01	<p>EFT Taxpayer Identification Number</p> <ul style="list-style-type: none">• The first seven digits are your FTB California corporation number from your registration confirmation letter (FTB 3824).• The last five digits are an FTB system-generated code, referred to as your posting control. We use it internally to help identify corporation accounts. If these last five digits of your Identification Number contain an asterisk, it must be included (in addition to the separator) to ensure proper posting.
TXP02	<p>Tax Type Code</p> <p>Please refer to the <i>Tax Type Codes</i> (FTB 3826). The left column lists the types of payments being made by EFT. The column on the right lists the five digit code for each payment.</p>
TXP03	<p>Income Year Ending Date</p> <p>Income year ending date for the year of the tax liability.</p> <p>YY - Income year MM - 01-12 are valid entries. DD - Enter the last day of the month for the income year ending.</p> <p>Tax Withheld at Source payments are always reported on a calendar year basis.</p> <p>The date for Nonadmitted Insurance Tax payments is the month/year for the quarter in which the payment is being made.</p>
TXP04	<p>Amount Type</p> <p>Always enter "T"</p>
TXP05	<p>Amount</p> <p>The amount of your payment including cents. Do not include a decimal point to denote the cents.</p>
